Old Business:

- A. Web Site D. Johnson reported that we are starting to update the web-site on the searchable data base. The calendar is now up and running, with dates that include the GSTC, the CTE Prep course, the CTE test date and the application deadline date.
- B. Legislative support for rules D. Johnson reported a letter of support for starting the rules now as opposed to 2014 was sent by Senator Gordon to the DEP Commissioner. Also, another letter signed by 10 or 12 legislators (sponsors and co-sponsors of the original bill) from the Senate and the Assembly was sent to the DEP Commissioner as well in support of starting the rules.

New Business:

- A. CTE Exam Update D. Johnson has been reviewing the exam, taking in to consideration the percentage of each of the sections of the test. This was previously suggested at the February Board meeting by Malcolm McBurney, CTE #566. D. Johnson reported the tree risk assessment section will be expanded as per a previous board discussion. G. Lovallo reaffirmed that cabling and bracing be on the CTE/LTE exam as this is one of the differences between the LTE and the LTCO. The Board discussed the continued development and review of the test. D. Johnson reminded the Board that the establishment of an examination subcommittee was previously discussed. D. Johnson will draft a break down of the percentages each section represents of the total exam for discussion by the Board at the next meeting.
- B. A3767 and amended A3654 D. Johnson handed out recent articles concerning utilities and trees. The articles included, helicopter pruning being employed by the utility companies and that JCLP spent over 200 million of infrastructure upgrades. D. Johnson explained to the Board the differences between A-3767 and the amended version of A-3654. Shade Tree Federation sent a letter to the sponsor listing concerns on the amended version of A-3654. The CAA reached out to the Green Industry Council for assistance with the bills and CAA members met with Assemblywoman Wagner to discuss and try to halt further movement of those bills. The Board discussed that maybe it was time that the Board of Public Utilities sit down with the

Board of Tree Experts to discuss vegetative management, trees and utilities lines.

C. Other – J. Greipp stated that the web-site looks great. G. Lovallo suggested that the board review the regulations/rules on stump grinding and provide a "Board Recommendations" to the industry.
