The Board was reminded that in 2014, individuals from five surrounding states took the CTE Exam. The CTE prep course has started with 23 individuals taking the first class. Old Business:

- A. Draft Rules, Impact and Summary Statements S. Chisholm thanked DAG Dalia for the excellent write up concerning the legislative and administrative history of the Board. This document was then provided to DEP Chief Advisor, Ray Cantor and to Assemblyman Ron Dancer. S. Chisholm informed the Board that a conference call to discuss the movement of the LTE/LTCO rules occurred between Mr. Cantor, Assemblyman Dancer and himself. A face to face meeting will occur in May between the three parties.
- B. BTE Audit update S. Chisholm reported that the draft audit report was sent to Treasurer D. Johnson. The report needs to be reviewed, however there seems to be a number of inaccuracies and a number of points that need to be addressed with the auditors. Each Board member will receive a copy. A follow up meeting with the Auditors will be pursued
- C. HomeAdvisor.com M. D'Errico explained several phone calls the office received from a CTE and a representative from HomeAdvisor.com over the listing of tree experts and tree care services in New Jersey on the HomeAdvisor.com web site. HomeAdvisor wants to correctly list individuals doing tree care services in New Jersey following the law and the requirements of the Board. Home Advisors' were informed of the pending rule process and the LTE/LTCO law. Once the rules are approved, HomeAdvisor will start to only list tree care companies that are in compliance with the law.
- D. CTE Test Subcommittee The Board was reminded that the 2015 CTE exam is under review by the Board's CTE Test subcommittee and that the subcommittee's comments concerning the exam needs to be provided shortly.
