- VII. **Old Business**: The Board requests updated status on pending issues to create a trail of interest.
  - A. **Brochures**: Changes were made to the original business brochure and a copy was provided for the board's review.
  - B. Business Registration deadline of October 14: The deadline was for business registration renewal was October 14, 2019. The Board was provided with a list of 130 Businesses who as of the 14th did not renew their business registrations. Under the Board's rules businesses who do not renew by the registration deadline are immediately suspended and penalties may be issued as per the law. Discussion: G. Lovallo suggests a 10-day grace period, with a letter be sent to each of the 130 businesses giving them 10 calendar days to submit their complete business registration packet. The Board approved the notification letter with a 10day grace period. The Board then discussed the use of a first NVOS Violation, allow 10 days for response. After 10 days and no response, issue \$500.00 penalty with 20-day response time allowed. No response after 20 days \$225.00 renewal fee and \$1,000.00 penalty with an inspection. This will be the final notice. Motion to send in this order by G. Lovallo, seconded by P. Zipse. Motion Passed.
