15. DEADLINE FOR LTE LICENSE RENEWAL: **December 31, 2023**

**Please Note:**

A) **After December 31, 2023**, a late fee of \$25.00 shall be applied to the Licensee fee of \$150.00 for a total amount of \$175.00.

B) **After January 30, 2024**, if the Board does not receive a completed LTE License renewal application form, CEU supporting documents, renewal fee, and late fee; **the LTE License will be suspended, and the Licensee may be subject to civil administrative penalties.**
